

We will start by hearing a little quilt history, quilting during slavery, and after emancipation. Then Karen will move on to how she got started as a quilter, just how she became a quilt diva. We will learn what inspires Karen, and how she gets started when facing a blank design wall. Part of the presentation will feature Karen's fabulous trunk show of her own incredible quilts and wearable art.

Truly a diva, Karen is happiest when she's sharing her love of quilting with others, which is why she enjoys teaching so much. Quilting is an art form that encourages sharing. When she first started quilting, Karen didn't think of quilting as an art form. But when she was invited to participate in an open studio with several other artists, it was an eye-opening experience. Now she says that "making art is the most fun you can have that's legal!"

LITTLE RIVER QUILT SHOW

Partners Gallery at Glendeven in Little River is proud to present an exhibition of the handquilted work of six North Coast artists, encompassing a variety of approaches to this ancient art. Works include the spontaneous and vibrant designs of Rita Martinez, the curvilinear designs of Catherine Booth, Amber Bell's small framed pieces exploring ideas of community, Ronnie Kemper's imaginatively colored contemporary designs, Julie Burns' explorations of Chinese lattice design and Shirlee Paoli's works embellishing traditional quilting ideas using recycled materials.

Also on view are works by gallery artists in a variety of media, Carleton Design hand-made carpets, and Christiansen-Arner water sculptures.

The reception is March 8, 5:00—8:00 p.m. This is, unfortunately, the same date as our Challenge opening, but the show will hang from March 6 through April 7, so there will be ample opportunity to see it.

Anna Hines reports that quilts submitted to the Ultimate Challenge will be insured for up to \$1000 while they are hung at the show, or more if a certified appraisal is submitted.

It is suggested that the quilts be shipped registered mail and insured for the quilt's value. The Post Office reports that an appraisal, a bill of sale, or evidence of the value of a similar quilt will all be accepted as proof of the quilt's value.

GUILD GLIMMERS

"I am an artist," said Merle Axelrad Serlin at the beginning of her lecture last month. Her ability to make that statement was the subject of her talk, which described her journey from amateur quilter to unqualified quilt artist.

Like many of us, she began without aspirations to artistry and made mostly baby quilts. Seeing his own quilt displayed in a show, her young show once queried, "Have all the quilts here been peed on?"

However, her talent quickly shone through and she began winning ribbons in various quilt shows. Buoyed by this success, she made her first sale to a Kaiser Hospital, and from that point, she never looked back. As her quilts developed their own unique voice, she became more and more successful in marketing them. Her collages of rocks and water, and later, trees, are joyous examples of a sensibility that continues to explore and grow.

Merle told the story of being at a luncheon in her Temple, and, when someone asked "What do you do?" simplified the answer by saying "I am an artist." For a moment — having said this in Temple! — she waited for a Voice From Above to challenge the blasphemy! When that didn't happen, she began to realize what all of us who saw her work already knew: she is an artist of the highest
